GENERAL ELECTION INFORMATION

Election of the Mayor is held every four years. Elections for City Council are held every two years with two of the four seats up for election. City Council members and the Mayor serve four year terms of office. These are paid positions, per WCC 1-6-4, with the current salary of \$250 per month for Mayor, \$150 per month for Council President and \$125 per month for Councilmember. City Council meets the second Tuesday of each month at 6:00 p.m. and then for any special meetings called by the Mayor.

The next election for Mayor and City Council will occur on November 5, 2019 from 8:00 a.m. to 8:00 p.m. MST.

A candidate has to declare that he/she is a qualified elector and the qualifications of a registered elector are as follows:

Resident of City of Wilder within the corporate limits of the City, and;

Registered Voter:

Eighteen (18) years old;

Candidate has to file a completed declaration of candidacy accompanied by (1) a petition of candidacy signed by not less than five (5) registered qualified electors;

or

(2) a non-refundable filing fee of forty dollars (\$40).

The Declaration of Candidacy period is **Monday, August 26, 2019 8:00 a.m. thru Friday, September 6, 2019 5:00 p.m.** Forms are available at the City Clerk's Office. The Declaration of Candidacy form must be turned into the Wilder City Clerk's Office located at 107 4th Street, Wilder, Idaho 83676. If the candidate wishes to submit the Declaration of Candidacy signed by not less than five (5) registered qualified electors, the form **must** first be verified by the Canyon County Elections office located at 1102 E. Chicago Street, Caldwell, Idaho 83605 prior to submittal at the Wilder City Clerk's Office. If the candidate wishes to pay the non-refundable filing fee of forty dollars (\$40), then the form is just submitted directly at the Wilder City Clerk's Office along with payment in cash.

The City of Wilder provides an election process that is open, fair, and responsive to the needs of all eligible citizens. We constantly strive to increase the accessibility and efficiency of the services we provide.
